- Provide a PRELIMINARY BUDGET, identifying approximate income and expenses including; 80/20 fee split of entry fees (host/PanAm), insurances, medals and awards, etc.
- Doping control is to be done by the host nation's WADA representatives. Cooperate with the doping control agency. Cost, payment and number of tests to be coordinated with the Pan-Am Executive. A minimum of 3 tests are required with 10% of entrants if possible.

2. **AGREEMENT SPECIFICATIONS**

2.1 **The Organizing Committee Agrees to:**

- Organize and operate the Pan-American Masters Weightlifting Championships as described in the Pan-American Masters Weightlifting Championships Guideline.
- Organize and operate the Pan American Masters Weightlifting Championships at a standard that meets the requirements to set Pan Am Masters records.
- Comply with current IWF Technical Rules, IWF Masters Rulebook and Pan Am Masters Rules.
- Contribute 20% of the Entry Fees received to the Pan Am Masters. The Pan Am Masters will submit an invoice for this payment which **must be paid in full within 30 days after the Competition.**
- Present a **Results Book** to the Pan Am Masters executive members and to the representative of each participating country at the closing banquet.
- Provide; awards, certificates, displays, flags and anthems, and closing banquet.
- Provide primary **medical care** for competitors and delegates in accordance with the requirements of the IWF Medical Committee Recommendations Section 5 Primary Medical Care For Competitors And Delegates.
- List items contained in the Guidelines and/or IWF Technical Rules and IWF Masters Rule Book, with which you propose not to comply.
